Working Well Workshop

Did you know that a poorly maintained water well can put your water supply at risk of contamination and reduce your well yield? If you are one of 450,000 Albertans who use their water well for household purposes, the key to ensuring your water supply is safe and secure is knowing how groundwater works, learning about your well, and understanding how to properly maintain it.

If you'd like to find out if your groundwater is at risk, and learn what you can do to protect your well, please attend a free water well management workshop being hosted by the Lakeland Agricultural Research Association, and presented by the Working Well Program, with technical expertise from Alberta Agriculture and Rural Development and Alberta Environment and Sustainable Resource Development.

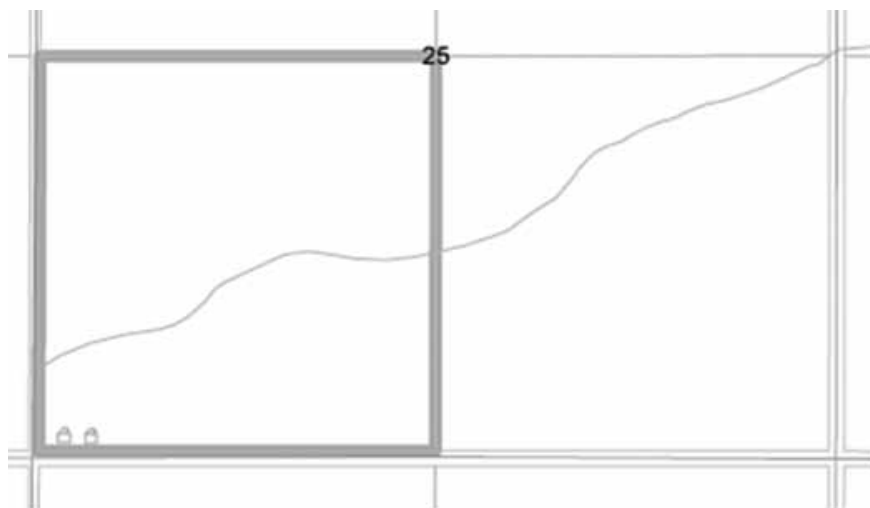
Take notice that the Council of the Municipal District of Bonnyville No. 87 is proposing to pass bylaws pursuant of Section 692 of the Municipal Government Act.

Bylaw LU 533 to amend Bylaw No. 1207 being the Municipal District of Bonnyville No. 87 Land Use Bylaw for South ½ of section 25-60-9-W4M (320 Acres more or less) from Agricultural 'A' to Direct Control 'DC' for the purpose of the development of a Hutterite Colony as shown on the attached Map LU 533

The Council will cause a Public Hearing to be held **Wednesday, November 27, 2013, at 10:00 A.M.** in the Council Chambers, Municipal Office, 4905-50 Avenue, Bonnyville, Alberta at which time objections to the proposed bylaws may be made and discussed.
