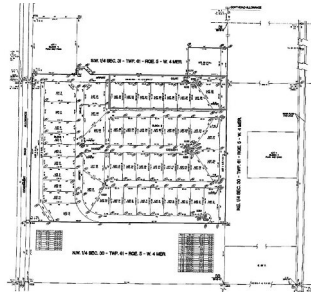
Bylaw No. 1207 being the Municipal District of Bonnyville No. 87 Land Use Bylaw is hereby amended as follows:

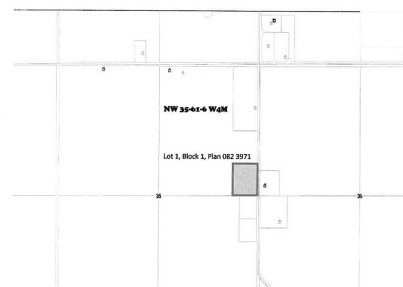
Bylaw No. 1207 being the Municipal District of Bonnyville No. 87 Land Use Bylaw is hereby amended as follows:

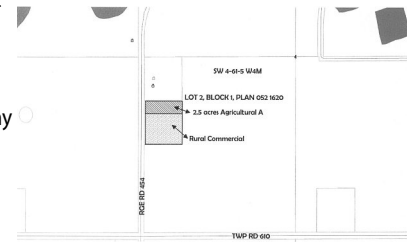
