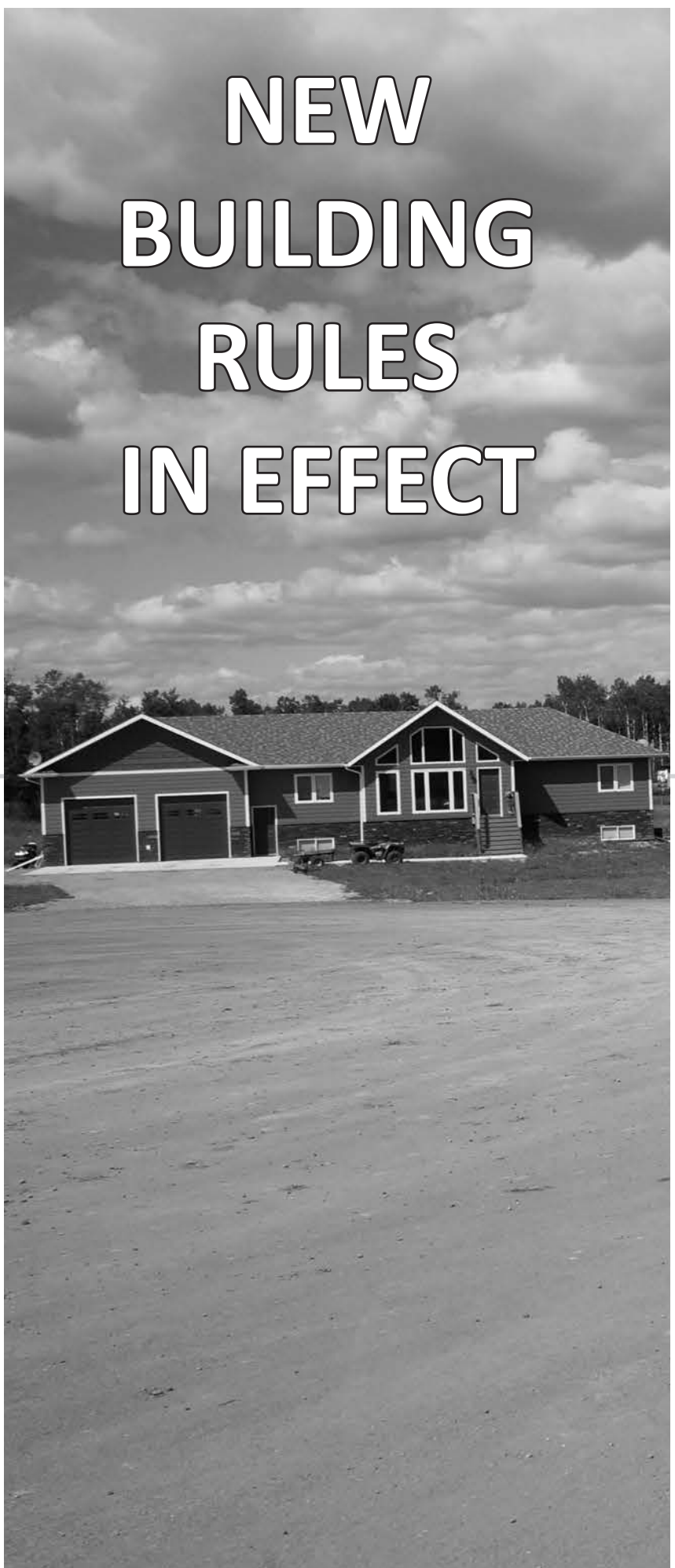

# NEW BUILDING RULES IN EFFECT



## NEW BUILDING RULES IN EFFECT

No new residential building permits will be issued by the municipality until builders acquire a New Home Warranty.

Starting February 1, 2014, every new home built in Alberta will require a New Home Warranty under Alberta's New Home Buyer Protection Act (NHBPA).
