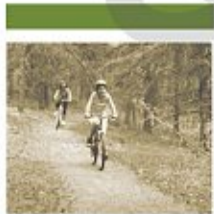

2015 MUNICIPAL DISTRICT OF BONNYVILLE GRASSHOPPER PROGRAM

The Municipal District of Bonnyville will be implementing the Grasshopper Program within the Municipal District of Bonnyville.

The Municipal District of Bonnyville will pay for the portion of road allowance to be sprayed only if the producer sprays their own field.

The Municipal District of Bonnyville prefers the road allowances to be sprayed by an aerial applicator or a high clearance custom applicator that has applicator's liability insurance in the amount of a minimum of \$2,000,000 and also Chemical Drift Liability.

The Municipal District of Bonnyville will be paying \$140 per 1/2 mile of road sprayed by aerial applicator that sprays both sides of the road. The high clearance sprayers will be paid \$70 per 1/2 mile due to spraying only one side of the road allowance.

Payments will be made to the custom applicator who must submit an invoice to the Municipal District of Bonnyville for miles that are sprayed.
