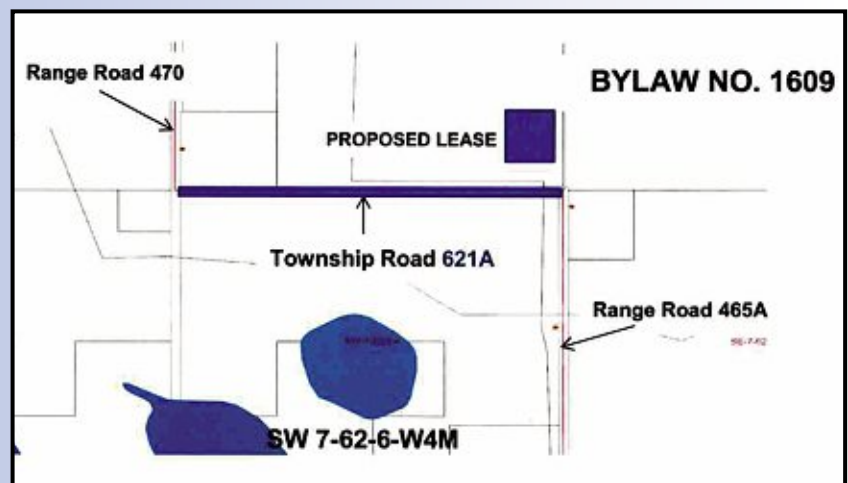
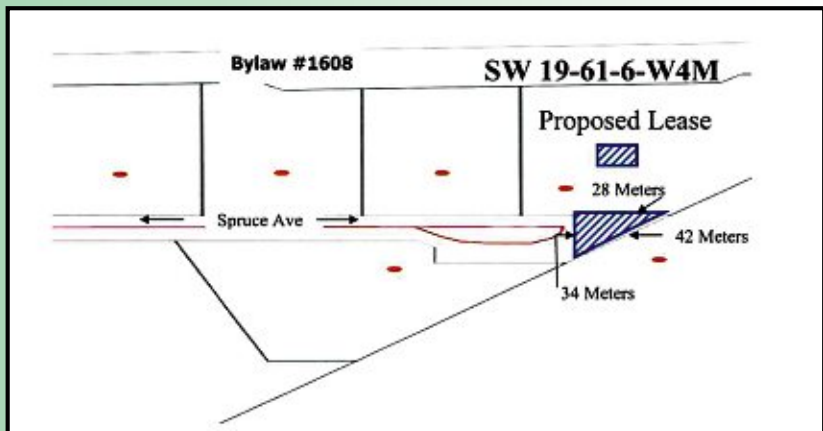
CLOSURE OF GOVERNMENT ROAD ALLOWANCE
