The Municipal District of Bonnyville will be selling liquid strychnine to qualified farmers for a set time each Friday during the closure of M.D. offices.

Starting March 27, farmers who have a verified gopher problem and are qualified by the M.D., will be able to buy strychnine from 8 a.m. to noon every Friday. This will be the only time the pest control measure will be available for purchase. If you are purchasing strychnine, please go to the Ag Services door on the side of the shop at 61330 Rge. Rd. 455.

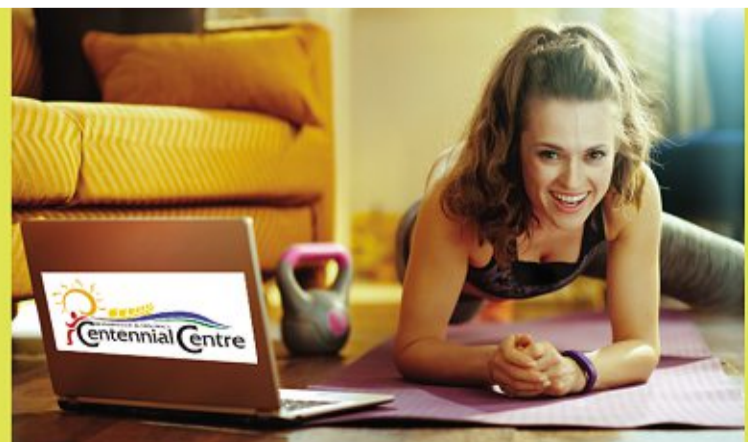
During this time, the M.D. will be billing individual farmers for the strychnine. No payments will be accepted in person.
