

BYLAW NO. 1366

BEING A BYLAW OF THE MUNICIPAL DISTRICT OF BONNYVILLE NO. 87, IN THE PROVINCE OF ALBERTA, TO AUTHORIZE THE RATES OF TAXATION TO BE LEVIED AGAINST ASSESSABLE PROPERTY WITHIN THE MUNICIPAL DISTRICT OF BONNYVILLE NO. 87 FOR THE 2007 TAXATION YEAR

WHEREAS the Municipal District of Bonnyville No. 87 has prepared and adopted detailed estimates of the municipal revenue and expenditures as required, at the Council meeting held on May 24, 2007.

WHEREAS the estimated municipal expenditures and transfers set out in the budget for the Municipal District of Bonnyville No. 87 for 2007 total \$56,948,773; and

WHEREAS the estimated municipal revenues and transfers from all sources other than taxation is estimated at \$24,122,589 and the balance of \$32,826,184 is to be raised by general municipal taxation; and

WHEREAS the Council of the Municipal District of Bonnyville No. 87 is required each year to levy on the assessed value of all property tax rates sufficient to meet the estimated expenditures and the requisitions; and

WHEREAS the Council is authorized to classify assessed property, and to establish different rates of taxation in respect to each class of property, subject to the Municipal Government Act, Chapter M26, Revised Statutes of Alberta, 2000; and

WHEREAS the assessed value of all property in the Municipal District of Bonnyville No. 87 as shown on the assessment roll is:

1. That the Chief Administrative Officer is hereby authorized to levy the following rates of taxation on the assessed value of all property a shown on the assessment roll of the Municipal District of Bonnyville No. 87.


